## CIRCULAR

Sub:- Higher Secondary Education-Conduct of Youth Festivals and Sports Meet-2011-12-Directions issued-reg.

Separate Youth Festival/Sports Meet was being held for the Higher Secondary Students from 1997-98 vide Government Order cited (1) above. As per the GO referred (2) above it has been decided to conduct the sports and games meet jointly for the students of High School, Higher Secondary and Vocational Higher Secondary instead of conducting separate competition by each department.

Government vide order cited (3) has accorded approval for the manual of "Kerala School Kalolsavam", for the conduct of the arts festival of students from Primary section to Higher Secondary section in a unified manner. Hence there will be no separate Youth Festival for Higher Secondary section alone as manual of the Higher Secondary Youth Festival has been nullified by the order cited (3). The manual of Kerala School Kalolsavam has been published in [www.educationkerala.gov.in](http://www.educationkerala.gov.in) the official web site of the Education Department of Kerala. The arts Festival of Higher Secondary students during the current academic year should be conducted together with High School and Primary Sections as specified in the Manual cited (3) above. It may also be noted that there has been Sub-District level arts Festival from the academic year 2008-09 onwards for the Higher Secondary Section also.

In this connection your attention is invited to the under mentioned utilization of fees collected from students and deposited by the Principals in PD/SB account during the academic year 2011-12

### **A) YOUTH FESTIVAL**

Those Principals who have not forwarded the proportionate amount of special fees of Youth Festival, Sports & Games fees of the previous years (ie, 2008-09 & 2009-10) are directed to draw the amount of Rs.34/- (Rs.16/-+Rs.18/-) out of special fee Rs.45/- (Rs.20/-+Rs.25/-) collected per student, being the share of the district level and the state level competitions of Youth Festival and Sports and games prior to the current academic year and to forward the same as mentioned above.
