ORDER

In the Budget for the year 2011-2012, an amount of Rs.1000/- lakh is provided under the Head of Account 4202-01-202-95 (P) and 4202-01-202-94(P) (One time ACA) for the Annual Plan Schemes of Higher Secondary Education and as per the Government of India letter 2nd cited, it is informed that Rs.1000/- lakh has been allocated under One Time Additional Central Assistance for the proposal and released 30% of the amount (Rs.3 Crore) for the year 2011-12.

As per the letter 1st cited the Director, Higher Secondary Education submitted proposal "Construction of Girls' Friendly Toilets in Government Higher Secondary Schools" for a total cost of Rs.1000/- lakh (Rs.400/- lakh under the Head of Account 4202-01-202-95 (P) and Rs.600/-lakh under the H/A 4202-01-202-94 (P) (One time ACA) for approval. The Special Working Group meeting held on 1.2.2012 approved the proposal for Rs.1000/- lakh on specific condition that approval of Ministry of Finance, release of funds and also subject to the general conditions laid down in the minutes of the Special Working Group. In the circumstance, Government are pleased to accord Administrative Sanction for the implementation of the proposal "Construction of Girls Friendly Toilets in Government Higher Secondary Schools" at a total cost of Rs.1000/- lakh.

The conditions for the implementation of the project are as follows:-

- 1). Implementation agency will be the concerned Local Self Government Institutions.
- 2). The Director, Higher Secondary Education shall release the funds to the concerned Local Self Government Institutions by way of D/D. The Director, Higher Secondary Education should monitor the implementation of the schemes and he should ensure that the implementation shall be as per the norms and procedures fixed by Government.
- 3). The works should be executed in a transparent manner observing all rules and procedures laid down in the PWD Code/Manuals/Stores Purchase Manual.
- 4). The Principals and concerned Local Self Government Institutions should ensure the availability of water throughout the school hours and the floors of toilets are tiled.
- 5). Additional period of six months from 31.3.2012 is granted for the implementation of the schemes.
- 6). Expenditure in this regard shall be met from the Budget provisions under the Heads of Account 4202-01-202-95 (P) and 4202-01-202-94 (P) (One time ACA).
- 7). The Director, Higher Secondary Education should furnish proposal for releasing fund.

In the Budget for the year 2011-2012, an amount of Rs.400/- lakh has been provided under the Head of Account 4202-01-202-95 (P) and an amount of Rs.600/- lakh has been allocated under the Head of Account 4202-01-202-94(P) (One time ACA) for the Annual Plan Scheme 'Construction of Girls' Friendly Toilets in Government Higher Secondary Schools'. As per the G.O read as 1st paper above, Administrative Sanction has been accorded for the implementation of the scheme. As per the letter read as 2nd paper above Director, Higher Secondary Education has reported that in the tabulated portion of the G.O, in Sl.No.2 'One Time ACA' is wrongly mentioned with the Head of Account 4202-01-202-95 (P) instead of 4202-01-202-94 (P) and number of schools is mentioned as '120 Higher Secondary Schools' instead of '80 Higher Secondary Schools'. In the Budget for the year 2011-2012, an amount of Rs.1000/- lakh was provided (Rs.600/-lakh under the H/A 4202-01 202-94 (P) (One time ACA) and Rs.400/- lakh under the Head of Account 4202-01 202-95 (P)) for the Annual Plan Scheme Infrastructure Development of Government Higher Secondary Schools. The Director, Higher Secondary Education submitted the proposal 'Construction of Girls' Friendly Toilets in Government Higher Secondary Schools' for Rs.10/- Crore and the Special Working Group held on 1.2.2012 approved the proposal with a request to forward proposal for releasing fund after issuing Administrative Sanction.
