ORDER

As per the Government Order read as 1st paper above, Government had ordered to enhance the remuneration/honorarium/special allowance to the teachers and other staff posted for the conduct of theory and practical examinations of Higher Secondary Examinations March 2005 onwards as detailed therein. Various Teachers Organization have been persistingly clamouring for enhancement of the remuneration ordered in the Government Order read above on the grounds that the existing wages are not in commensurate with the duties and responsibilities being performed by the Higher Secondary School Teachers in connection with the examination duties and that there is glaring inconsistency with the remuneration being paid to High School Teachers in connection with S.S.L.C examination duties.

2) Government have examined the matter in consultation with the Director of Higher Secondary Education vide his letter read as 2nd paper above and found that the grievances raised by the Teachers organization are genuine and warrant favorable consideration.

3) In the circumstances Government are pleased to grant 30% enhancement [except for valuation of answer scripts] in the existing remuneration fixed for the teachers and staff posted for various Higher Secondary Examination duties and valuation duties with effect from March 2012. The Director of Higher Secondary Education will issue separate proceedings showing the above hike on each item.

4) Government also order the following enhancement in the existing remuneration to the examiners for the valuation of answer scripts with effect from March 2012.

No	Item	Existing Rate	Enhanced Rate
1	Valuation of answer scripts other than Botany & Zoology	Rs. 5.50/- per script	Rs. 8/- per script
2	Valuation of Botany & Zoology answer Scripts	Rs. 4/- per script	Rs. 6/- per script


