### ORDER

In the Budget 2012-13 an amount of Rs.16 Crore has been provided under the Head of Account 2202-02-109-75 (P) for the infrastructure development of Government Higher Secondary Schools. As per the G.O read as 1<sup>st</sup> paper above sanction has been accorded for the re-appropriation of a sum of Rs.2,35,69,000/- from the Head of Account 2202-02-109-75 (P) to the Head of Account 2202-02-109-76 (One Time ACA) for the purchase of lab equipments and computers in Government Higher Secondary Schools.

2. As per the letter read as 2<sup>nd</sup> paper above, the Director, Higher Secondary Education submitted proposal for the construction of toilets and providing drinking water facilities in Government Higher Secondary Schools at a total cost of Rs.12,79,00,000/-, as per the following components.

3. The Special Working Group Meeting held on 1.3.2013 in the Chamber of the Principal Secretary, Finance Department approved the scheme at a total cost of Rs.12.79 Crore for the implementation of the same in the 530 Government Higher Secondary Schools (list appended)

4. In the above circumstances Government are pleased to accord Administrative Sanction for the implementation of the scheme 'Construction of toilets and providing drinking water facilities' in 530 Government Higher Secondary Schools (list appended) at a total cost of Rs.12.79 Crore with the following conditions.

- 1) Implementation agency will be the concerned Local Self Government Institutions.
- 2) The Director, Higher Secondary Education shall release the funds to the concerned Local Self Government Institutions by way of D/D. The Director, Higher Secondary Education should monitor the implementation of the schemes and he should ensure that the implementation shall be as per the norms and procedures fixed by Government.
- 3) The expenditure will be met from the current year's Budget provision available under the Head of Account 2202-02-109-75 (P).
- 4) Tender and other stipulated formalities shall be followed wherever necessary
- 5) Store Purchase Rules shall be strictly adhered to.
- 6) For civil works, Public Works Department Schedule of Rates shall be followed.
- 7) The Director, Higher Secondary Education should collect the Utilization Certificate from the concerned LSG Institutions and physical target, out put, outcome and deliverables of the scheme should be ensured.
- 8) The Time limit for the implementation of the scheme is extended upto 30.6.2013.
