<u>ORDER</u>

As per the G.O. Read as 1st paper above, Government have accorded sanction for the declaration of probation of those Lab Assistants who were appointed under by transfer and through direct recruitment up to 28/03/2003 and who had not passed the Lab Attender Test conducted by Kerala Public Service Commission but completed their period of probation satisfactorily, otherwise. The above Government Order was issued subject to the condition that the Lab Assistants would have to pass the Lab Attender Test conducted by Kerala Public Service Commission within 3 consecutive years. It has also been ordered theirin that in case of failure to acquire the qualification, their further retention in service will be reviewed by Government, as the pass in Lab Attender Test is a minimum required qualification for the post of Lab Assistant.

(2) It has since been brought to the notice of Government that Kerala Public Service Commission has conducted Lab Attender Test only twice since the issuance of the said Government Order ie in 2007 and 2010.

- (3) Due to the above reasons the probation of large number of Lab Assistants who were appointed prior to the issuance of the above Government Order and thereafter can not be declared that they have satisfactorily completed their period of probation in the cadre of Lab Assistant. Consequently, they are denied the benefit of annual increment eligible Higher Grade etc.
- (4) Government have examined the matter in detail with reference to the relevant rules and orders and are pleased to extend the benefit of orders issued in the G.O. yead as 1st paper above to those Lab Assistants who are appointed upto the date of this Government Order.
- The above order will be subject to the condition specified in the G.O. read as 1st paper above.
