ORDER

In the Writ Petitions read as 4th paper above, the petitioners have inter alia prayed for a direction to include them under Statutory Pension Scheme after excluding them from Contributory Pension Scheme introduced as per the Government Order read 5 paper above. The Petitioners in the relevant WP(C) were appointed in sanctioned posts. Since posts were created at the fag end of the academic year 2012-13, ie on 23.2.2013, they are not entitled to get approval of appointment on that date, but from the next academic year only. Such teachers become expelled from the statutory pension scheme.

Government have examined the matter in detail with respect to the relevant rules and orders. As national pension system is mandatory to all appointments made on or after 01.04.2013,
