Enquiries regarding the remittance/utilization of special fees collected from students are often received in this office, especially from the newly sanctioned schools. The different items of fee to be remitted under general revenue/ PD Account are detailed in Para (1) and the guidelines for utilization of specified items of special fee in Para (3) of G.O (Ms) No.124/98/Gl. Edn dated.21/4/1998. (The rates noted in this G.O have been enhanced as per G.O (Ms) No.173/2013/Gl. Edn dated.20/5/2013).

Principals can utilize the special fees collected from students, during the financial year of its collection, as per guidelines in the G.O dated 21.04.1998. For utilization of the unspent balance after the lapse of the financial year, sanction from government is required.

The items falling under 'General Revenue' must be remitted under the Head of Account '0202-01-102-97-01 tuition fees & other fees'.

Further it is informed that , as per G.O (Ms) No 208/08/Fin dated 13/05/2008, heads of all government and aided Higher Secondary Schools are permitted to open PD Account with the respective treasuries.

Copies of the government orders dated.21/4/1998, 13/5/2008 and 20/5/2013 mentioned above are attached for the information of all the Principals.

the G. O. read as fourth paper it was clarified that the Audio Visual Unit fee, stationery fee; Association fee and Sports fee may be accounted for with Public Account under the nead of account "8443-123-Deposit of Educational Institutions". In the circular 5th read above it was ordered that the Heads of Government Higher Secondary Schools above are required to maintain Deposit Accounts under the above head for accounting all categories of special fees collected from the students from time to time and that the heads of Alded and Unaided Schools will have the option to remit all categories of special fees collected from the students in Treasury Savings Bank Accounts opened for the purpose the opening of which does not require sanction from the Accountant General.

3. Eventhough special fees are thus collected from the students in Government/ Aided Higher Secondary Schools and the amounts remitted in PD Accounts and Tre sury Savings Bank Accounts respectively, no amount is utilised for the purpose for which it is collected. The Director of Higher Secondary Education has therefore requested Government to issue necessary orders permitting the Principals to utilise the special fee collected from students which are being remitted to P. D. Accounts/ TSB Accounts after prescribed necessary guidelines in the matter, in this connection he has recommended utilization of the specified items of special fees as follows:-

- (1) Audio-Visual Unit fee: For showing Audio-Visual programme to students and for the purpose of different kinds of equipments such as Mikesets, Projection TV
- (2) Stationery fee:- For the purchase of Stationery Items such as Duster, Chalks etc. and for the printing of question papers.
- (3) Association fee: For the promotion of Union activities among students.
- (4) Sports fee:- Fer, or anising sports activities including purchase of sports goods and also for providing TA/DA/ to Atheletes who participate in various levels of
- (5) Atheletic Meet Arts/Youth Festival fee:- For organising atheletic meet and for the promotion of Art and Cultural activities of students.
- Government have examined the matter in detail and are pleased to accord sanction for the utilization of the special fees mentioned above which are being collected from students in Govt. /Aided Hr. Secondary Schools and remitted in P. D. Accounts/TSB Accounts as the case may be for the specific purpose as to commended by the DHSE subject to the condition that the rules/guidelines being followed in Govt./ Alded colleges for regulating the collection custody and disposal of Spl. fees issued .in G. O. Ms. 312/83/H. Edn. di., 30-12-83 will be adopted in the Govt./Aided Hr. Secondary School for the purpose.
