### ORDER

The Vigilance and Anti-Corruption Bureau, Alappuzha Unit conducted a Quick Verification regarding the allegation of misappropriation of funds issued for the remittance of various fees of SC/ST and OEC students from Scheduled Caste Department as E-grantz by the Principal, Government Boys Higher Secondary School, Kayamkulam. During Quick Verification, it was revealed that Smt.Sherlykutty.T.Molickal, Principal of the above school abused her official position and misappropriated an amount of ₹ 3,50,350/- (Rupees Three Lakhs Fifty Thousand Three Hundred and Fifty only) entrusted to her from the SC Department for payment of various fees of SC/ST and OEC students during the period from 01/06/2010 to 20/01/2016 by not remitting the fees to Sub-Treasury, Kayamkulam after withdrawing it from E-grantz bank account. The Quick Verification also revealed that the Principal abused her official position as public servant and misappropriated Government money entrusted to her. Hence a Vigilance Case (VC.10/16/ALP) was registered against Smt.Sherlykutty.T.Molickal, Principal, Government Higher Secondary School, Kayamkulam. Since the accused is in charge as Principal of the school, there is every chance that she may tamper with evidence and influence witnesses, which may cause hindrance to the smooth investigation. Therefore, the Director, Vigilance and Anti-Corruption Bureau has recommended to transfer the accused Smt. Sherlykutty T Molickal out of Government Higher Secondary School, Kayamkulam.


