ORDER

As per Rule 5 of Chapter XXXII, KERs, appointments in teaching posts have to be made on the recommendation of a selection committee consisting of the Manager or his nominee (Chairman), Principal of the school and a representative of the Government selected by the Manager from a panel of officers not below the rank of a Deputy Collector or officers not below the rank of a Deputy Secretary to Government, prepared and maintained by the Director of Higher Secondary Education for every academic year. allegations/representations, Government Based certain regulations/modifications in the matter of appointment of Government representatives to the selection committees as per the Government Orders read as 1st to 6th papers above.

- 2) The Manager, SN Trust Schools, Kollam as per letter read as 7th paper above has pointed out certain difficulties in constituting the Selection Committees for the appointment of HSSTs. Government also noticed some issues/difficulties on the part of Government and Managers of the schools in the above matter.
 - 3) In the circumstance, the following modification/regulations are ordered:
 - The Managers shall submit the request for the appointment of Government representatives to the Regional Deputy Director concerned along with the copies of the documents showing the details of occurrence of post/vacancy.
 - ii. The Regional Deputy Director shall ensure the veracity of details of vacancy and furnish a proposal with specific recommendation to

Government through Director of Higher Secondary Education for appointment of Government representative.

iii. The Manager shall fix a date for the selection committee meeting only after the issuance of the Government Order regarding the appointment of Government representative to his school.

- iv. A Government representative nominated in the selection committee in aided higher secondary schools can attend in a maximum number of 12 selection committee meetings in an academic year and the number of vacancies to which selection is made by a single selection committee will be 10.
- 4) The above modifications will come to effect from the academic year 2016-17 onwards.
- 5) The Regional Deputy Directors and Director of Higher Secondary Education will bring to the notice of the Government any instance of violation of the above Government Orders, then and there.
- 6) The Government Order read as 6th paper stands modified to the above extent only.
