ORDER

As per GO read as third paper above orders were issued exempting officers of Higher Secondary Education Department, General Education Department and General Education Department of Administrative Secretariat from becoming members of Selection Committee to be constituted by the management of Higher Secondary Schools for Selection to the post of Higher Secondary School Teachers.

2. As per the representation read as fifth and sixth above it has been represented to Government that consequent on the prevalence of the orders issued in the Government Order read as 3rd paper above much difficulty is experienced in getting competent and experienced officials for formation of Selection Committee. It has been further stated that due to this the procedures for appointment to the post of Higher Secondary School Teacher often get delayed. The General Manager, SNDP Yogam Schools and General Secretary KHSTU has therefore requested Government to revoke the above Government Order.

3. Government have examined the matter in detail and are pleased to allow the officers of and above the rank of Deputy Secretary of Education Department including General Education Department of Administrative Secretariat to participate in the Selection Committee for Selection to the post of Higher Secondary School Teacher subject to the following conditions.

- 1) No Officer should attend the Selection Committee without prior sanction of Government.
- 2) An Officer nominated will not attend more than 4 Selection Committees during an Academic Year.
- 3) The nominated officer after attending the Selection Committee should submit a report to Government within 2 weeks from the date of interview.
4. The orders issued in the GO read as third paper above stands cancelled with immediate effect.


